- 3) Each equipment shall be marked either by raised lettering cast integrally or by plate attached permanently to the main structure to indicate conspicuously:-
 - (a) Name of the manufacturer
 - (b) Name and number by which the equipment is identified.
 - (c) Number & date of the test report of the CSA applicable to the equipment.
 - (d) Equipment reference number of this letter by which use of apparatus is approved.
 - (e) Protection level.
- 4) A certificate to the effect that the equipment has been manufactured strictly in accordance with the drawing referred to in the Test report and is identical with the one tested and certified at Testing agency shall be furnished with each equipment.
- 5) The customer shall be supplied with a copy of this letter, an extract of the conditions and maintenance schedule, if any, recommended by CSA and copy of instructions booklet detailing operation & maintenance of the equipment so as to maintain its safe characteristics.
- 6) The IS/IEC 60079-17 and IS/IEC 60079-19 shall be followed for maintenance and repair of overhaul of the subject equipments.

Conditions of the Approval:-

- 1.This component is NOT intended to be used alone and requires additional consideration when incorporated into other equipment or systems for use in explosive atmospheres (refer to IEC 60079-0).
- 2.The specific conditions of use as mentioned in IECEx test report/COC No. IECEx CSA 24.0046U , dated 13/5/2025 shall be communicated to the end user and same to be followed strictly .

This approval also covers the permissible variations as approved under the CSA test reports referred above. This approval is liable to be cancelled if any of the conditions of the approval is violated or not complied with . The approval may also be amended or withdrawn at any time, if considered necessary in the interest of safety.
